Dividend amounts reflect the annualized rate on a per-quarter basis and may differ slightly from the rates reported in these filings, which were calculated on a daily basis and therefore vary based on the number of days in each quarter.

<sup>3</sup>For 2016, 4.59% of the amount reflected in Box 1a on Form 1099-DIV represents a Qualified Dividend and will be reflected in Box 1b on Form 1099-DIV.
